The Latimer Lane School renovation project has received approval from the state grant agency to pre-purchase several key building materials with known long lead times. As that bidding begins, the project now seeks authorization to bid the remaining services and materials necessary to implement the addition and renovation work. To advance this effort, the Simsbury Board of Education (and likewise the Public Building Committee) must vote to approve the bid documents before the state grant agency will provide authorization to bid the work.
