Twelve-month employees will have tax sheltered annuity deductions in July and August, and then will follow the schedule of ten-month employees for the remainder of the year with regard to all other deductions. Only NAGE and SSASA members working twelve months will have dues deducted during July and August.

All deductions for ten-month employees such as TSA (403b), dues, flexible benefits, insurance and HSA contributions will be taken from 20 paychecks starting with the 09/09/2022 payroll.

**THERE WILL BE NO DEDUCTIONS TAKEN EXCEPT FOR MANDATORY TAXES ON THE *THIRD PAYROLL OF THE MONTH* WHICH INCLUDES 07/29/2022, 12/30/2022 AND 06/30/2023.**
